Emergency Procedures

Wear PPE in accordance with Section 8 of this SDS. Minor spills: Isolate ignition sources. Avoid inhalation of vapours or dust. Wipe up with absorbent (clean rag or paper towels). Collect and seal in properly labelled containers or drums for disposal.

In the event of a major spill, prevent spillage from entering drains or water courses. Isolate ignition sources. Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. As a water-based product, if spilt on electrical equipment the product will cause short-circuits. If possible, contain the spill. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.
