## SECTION 4 – FIRST AID MEASURES

<b>Inhalation</b>	Remove person to fresh air away from exposure. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Obtain medical attention if symptoms occur.

## SECTION 7 – HANDLING AND STORAGE

<b>Handling</b>	Avoid skin or eye contact with concentrate. Wear protective clothing when risk of exposure occurs. Avoid contact with incompatible materials. When handling, DO NOT eat, drink or smoke. Keep containers closed at all times. Avoid physical damage to containers. Always wash hands with water after handling. Launder contaminated clothing before re-use.
<b>Storage</b>	Store in a cool, dry, well-ventilated place and out of direct sunlight. Store away from foodstuffs. Store away from incompatible materials described in Section 10. Store away from sources of heat and/or ignition. Keep container standing upright. Keep containers closed when not in use - check regularly for leaks.
